#### CONTEXT AND JUSTIFICATION

The Local Governance and Resilient Communities Project (PROLOG) is being implemented by the Government of the Republic of Cameroon with technical and financial support from the World Bank (WB). The project will last five years and cost approximately US\$300 million, or nearly FCFA 189 billion. The project operates in six regions: Adamawa, East, Far North, North, Northwest, and Southwest.

The Project Development Objective (PDO) is to improve the socioeconomic inclusion and resilience of vulnerable communities and strengthen local governance and beneficiary engagement in service delivery.

PROLOG is based on two key intervention pillars: (i) direct interventions at the community level to improve community and inter-communal infrastructure and (ii) capacity building of decentralized local entities. It will combine support for decentralization efforts with bottom-up development commitments to strengthen community autonomy, including improving and strengthening the climate resilience of community infrastructure and access to basic services. The Project covers six (06) Regions of Cameroon, namely the Adamawa, East, Far North, North, North West and South west Regions. PROLOG is implemented under the supervision of the Ministry of Decentralization and Local Development (MINDDEVEL).

#### I. OBJECTIVE OF THE STUDY

The general objective of the mission is the mobilization of technical assistance in order to support communities in awareness-raising, structuring and local planning for the implementation of PROLOG activities.

#### II. CONSULTANT'S MISSION

- To conduct a diagnosis of the existence of Neighborhood Committees or Village Committees, their functionality, and their level of structure in terms of establishing Village or Neighborhood Committees (VC/NC);
- To structure Village Committees (VC) or Neighborhood Committees (NC) in accordance with Order No. 00000147 of July 19, 2023, on the organization and operation of village and neighborhood committees where they do not yet exist, and to revitalize them where they have been created and are inactive;
- To raise awareness among communities about the project's content, expected results, and implementation modalities, emphasizing the project's expectations of the community, including the inclusion of all social strata, consideration of gender and vulnerable groups (refugees and internally displaced persons), consideration of adaptation to climate change, the inclusion of women and youth, etc.; - Raise awareness among communities about self-assessment of security risks, the identification of climate-resilient sub-projects, and sustainability issues (upkeep and maintenance of structures, etc.);



- Support communities in formulating their Community Action Plans (CAPs) that integrate climate change by transferring local planning skills;
- Assist VCs/NCs in identifying their priority infrastructure needs;
- Build the capacity of VCs/NCs members in simplified management and basic skills;
- Train VCs/NCs members in basic skills (organizational and managerial capacities);
- Support communities in conducting climate and environmental screening;
- Support communities in formulating Community Action Plans (CAPs) with climate risk assessments and the development of an environmental management plan;
- Support VCs/NCs in selecting priority community investments and infrastructure to be submitted for PROLOG funding.
- Support VCs/NCs in the maturation of sub-projects.

### III. EXPECTED RESULTS

At the end of this study, we will have:

- Diagnostic reports on the establishment and operation of the VCs/NCs of the targeted communities are available;
- The VCs/NCs are established, structured, and operational;
- A description of the process for selecting the VCs/NCs to be revitalized based on the project criteria is developed;
- The exact number of VCs/NCs for these municipalities is known;
- A document containing the VC/NC awareness-raising strategies is available and will serve as a basic document for community training;
- Priority infrastructure needs are identified by the VCs/NCs;
- The capacities of VC/NC members in simplified management aspects and basic skills (managerial and organizational capacities) are strengthened;
- The VCs/NCs have Community Action Plans (CAPs) including environmental and social management plans;
- The VCs/NCs each have an investment plan and priority infrastructure.

### IV. METHODOLOGICAL APPROACH

## **VII. PROFILE OF THE CONSULTANTS SOUGHT**

The Consultant must be a Non-Governmental Organization (NGO), a Technical Support Structure (TSS), a Local Support Organization (LSO), a Consulting Firm, an association, or any legal organization with proven skills and experience in the field. The Consultant will be selected based on the following criteria:

### **a. General Criteria:**

- Demonstrate legal existence and the capacity to enter into contracts;
- Demonstrate the Consultant's participation in community development support activities and have a sufficient number of qualified, experienced human resources;
- Have successfully supported (services completed under good conditions) one or more municipalities in structuring communities;
- Demonstrate the completion of at least two (02) similar missions;
- Have a good knowledge of the southwest Region and the municipalities where the mission will be carried out.

### **b. Technical criteria:**

- **Institutional:** Must have a geographical presence in the North West Region and enjoy established credibility with beneficiaries, as demonstrated by satisfaction certificates for services provided;

- **Financial:** Must have established cash flow to cover pre-financing of activities pending payment of services;

- **Sustainability:** Must be able to develop a participatory approach (based on a sound understanding of the environment);

- **Social:** Must understand the sociological characteristics of the different communities and have staff capable of communicating in the local language.

The experts proposed by the firm must have complementary profiles and the following minimum qualifications: (See Terms of Reference)

In addition, all consultants must demonstrate:

- Sound knowledge of data collection and analysis methods, and the detailed presentation of results;
- Proven experience in community engagement;
- Good writing and synthesis skills.

A good understanding of the Cameroonian context is an asset.
